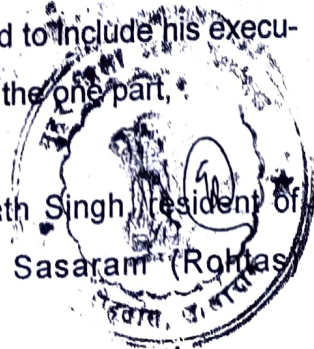

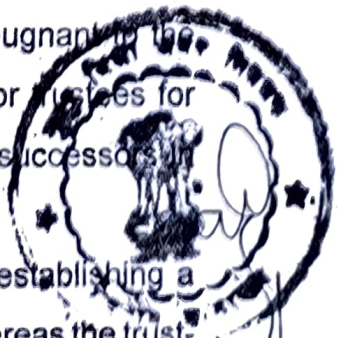

Now this indenture witnessth as follows :-

1. (a) That the trust created by these presents shall be **DEDICATED INTERNATIONAL EDUCATIONAL TRUST (DIET)** and its corporate office shall, for these presents will be located that DINA VIHAR, BANSA, KARWANDIA, SASARAM (ROHTAS) BIHAR-821316

(b) **Working area : All over India**

2. That, in under to effectuate his aforesaid desire, these, the founder has set apart and handed over to the trustees out of his inherited property, a sum of Rs. 10000.00 (Rupees Ten thousand only) (hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of the kind whatsoever into which the same or any thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these present), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.

3. AIMS AND OBJECTIVES :

(a) To establish, develop, maintain and granted aid in cash or in kind to Schools, Colleges, Nursing Institutions, B.Ed College, Hospital, Medical Institution, Vocational Course Programme, Training School/College for PTT, Education etc, Dispensaries, Maternity Homes, Child Welfare Rehabilitation of Old age home/and or such other similar Charitable Institutions in India for the benefit and use of the general public.

- (b) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading room, universities, laboratories, research Centers and other institutions of the kind like nature in India, for use of the students and the staff and also for the development and advancement of education of knowledge among the public in general.
- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without distinction as to caste colour, race creed or sex.
- (d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institution in India, having similar objects for the benefit of the public in general.
- (e) To establish, maintain or grant aid for the establishment and / or maintenance of dharmashala and rest house, for use by public in general.
- (f) To establish, maintain or grants aid to homes for aged, orphan age or other establishment for the relief and help to poor, needy and destitute people, orphans, widows and aged persons.
- (g) To establish and develop institutions for the physically handicapped/Challenged and disabled or mentally retarded persons and to provide them education, food, clothing and other help.
- (h) To grant relief and assistance to the needy persons during natural calamities such as famine, earth quake, flood, fire pestilence etc and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- (i) To grant aid or render assistance to other public charitable and educational trusts or institutions.

4. That the Trust Fund shall not be applied for any purpose other than specified in para 3 hereinabove.
5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.
6. That the trustee shall always maintain proper accounts of the trust, which shall be kept at the office of the trust.
7. That for the furtherance of the objects of the trust, the trustees shall have the following powers :

a) To accept any donation, contribution, grant or subscription in cash or kind, from any person(s), body of persons or trust/society, Corporate Sector, with or without conditions.

b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.

To convert and deal with the trust property and / or any investment for the time being.

To open account in the name of the trust, trustee and /or Institutions run / conducted by the trust with a Bank or Banks, to operate such account and to give instruction to the bank and to provide for opening and operation of such account by one or more of the trustee or by an agent appointed by the trustee.

To set apart and/or allocate the whole or a part of the income or the corpus of the trust fund or part thereof for any of the objects of the trust.

To accept any Loan or Advance from any person(s), body of persons, or trust, bank, financial institution with or without conditions.

The Trustee shall be accountable only for such money, stocks and

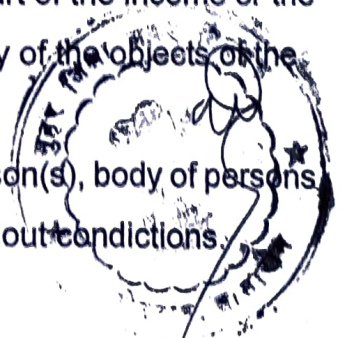

funds as shall actually come into their hands and a trustee shall not be answerable or accountable for neglects, defaults, acts or omission of the other Trustees or other person with whom the trust properties have been kept.

9. The Trustee may reimburse them selves all expences actually incurred by them in connection with the trust or their duties relating thereto .

10. The number of trustees shall not be less than two and more than seven. If the number of trustees shall fall below two, the trustee shall not, except for the purposes of filling any vacancy, act so long number is below the said minimum.

11. Every trustee will be at liberty to resign on giving one month's notice of his intention to do so.

The trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations.:

a) Two trustees shall form a quorum for a meeting of the trustees.

b) All matters will be decided mutually by the trustees.

c) Resolution passed without any meeting of the trustees but by circulation thereof by two thirds of the trustees shall be as valid and effectual as resolution duly passed at a meeting of trustees.

The accounting year of the Trust shall be the financial year ending on 31st march every year.

The Trust and the Trust funds shall be irrevocable for all times.

The founder shall hold have superintendence over the affairs of the Trust and shall have in particular the power to operate the bank account jointly with one of the other trustee as may be decided by the board of trustees.

Amendment : (1) Clause 15 of Old Bylaws regarding opening bank account was not clearly mentioned is amended in para 15 as :—

"Bank account will be operated by founder and anyone of the trustee jointly."

(2) Clause 15 (b) (c) of old bylaws regarding retirement of trustees have been removed by our board of trustees in para 12
